Vision & Strategy

Our vision is to be the leader in promoting and improving the wellbeing of maritime workers worldwide.

Our strategy for 2015-2019 focuses on funding four current campaign themes:

- **Ports of Call** – Seafarers have little time in ports and it is normally a busy time. The Trust ensures that services and facilities are provided in many of the world's ports by granting towards vehicles to transport the seafarers, by providing capital costs of drop-in centres and seafarers' centres.
- **Horizons** – Raising the standards of welfare on board ships during work and rest (leisure) times. These programmes include health, safety, nutrition, and FUN.
- **Beyond the Blue** – Initiatives targeting seafarers' home environment, including social work, scholarships, and micro finance.
- **SeaChange** – Working as a catalyst on social normative change. This includes research, conferences and promotion of seafarers' welfare in the wider community.



Vehicle Replacement Programme (VRP)

Once the survey is complete, we will be able to invite some Centre to apply to replace their vehicle for the Autumn session in 2018 and we will use the same data for the Spring and Autumn session of the VRP in 2019.

Funds are limited, so just some of the survey's participants will be invited to apply.

Completion of the survey does not constitute an application to the ITF Seafarers' Trust, nor does it guarantee future funding for a vehicle.

Nevertheless, your cooperation in completing this survey will help the Trust to more effectively and equitably distribute its funds and will ultimately lead to the improvement of seafarers' welfare worldwide.

The Trust will be then able to choose the vehicles that need to be replaced more urgently.

Seafarers' Emergency Fund (SEF)

The Seafarers Emergency Fund (SEF) has been set up by both The TK Foundation and the ITF Seafarers' Trust, administered by ISWAN.

The Fund provides immediate, essential aid to seafarers and families of seafarers, who are directly involved in sudden and unforeseen crises. This Fund is available to seafarer welfare organizations and other welfare organizations to provide the means to purchase goods and/or services for seafarers and/or the spouse or children of seafarers to relieve the need(s) brought on in relation with a sudden and unforeseen crisis.

The minimum grant available is \$250.00 USD whilst the maximum grant available is \$5,000 USD.

Portable Communication Pods



It is a portable 20ft container boxes providing seafarers with access to Wi-Fi, tablet consoles and furniture to rest. As the centres will be powered by solar panels, the centres will be both energy efficient and viable in areas lacking in existing infrastructure (where possible, the centres can also be connected to a mains power supply).



Onboard Online: Improving Port Connectivity

With smartphones now seemingly everywhere and with super fast broadband available at the flick of a switch, we have become accustomed to reliable internet connectivity. For many seafarers this is simply not the case given the lack of internet connection on board ships and in ports. The lack of reliable internet provision can cause isolation whilst at sea, creating quite serious wellbeing issues for the seafarers concerned.

This is the main reason that the Trust is now trying to improve seafarers' connectivity through a pilot project aptly called, Onboard Online.



Shore Leave


was first launched in 2014 and it was actually the very first app specifically developed for seafarers. The idea was to collect all the seafarers' centres contact details in an app, knowing that most seafarers cannot rely on an internet connection.

The app, once downloaded, was and still is functioning offline. All the contacts are stored in seafarers' phones and easily accessible at any time, so that they can always call for a bus to give them a ride to the seafarers' centre, mall or nearby city.

Port levies system

Port levies for welfare are one way of providing sustainable funding for seafarers' centres, ship visiting, and other welfare services ashore.

The Maritime Labour Convention (MLC, 2006) protects the welfare, living and employment conditions of seafarers all over the world.

The MLC's guidelines include, "levies or special dues from shipping sources" to pay for port welfare facilities.

A number of ports around the world, however, already operate welfare levies on a voluntary or compulsory basis, and many to good effect.
